RIGHTS AND RESPONSIBILITIES OF INDIVIDUAL BOARD MEMBERS

Responsibilities of Board Members:

- Must be willing to commit the time necessary to carry out the duties of a Board member
- Must be interested in increasing the health of Saskatchewan people through physical activity
- Must support collaborative action to reach a common goal
- Must be open-minded and respectful of the opinions of others
- Must be able to plan creatively and be able to direct the implementation of those plans
- Must have the initiative and ability to establish policies for the successful operation of the Association
- Should be a team player
- Demonstrate the shared values and beliefs that define acceptable Board behaviour and effectiveness
- Exercise diligence and independent judgement in the oversight of the Association as an active, energetic, and probing member of the Board of Directors
- Assume personal responsibility for acquainting themselves with the general trends of physical activity to inform strategic direction and fulfil the needs of the province

Qualifications:

- Be a member in good standing, or an employee of a member organization
- Believe in the purpose and vision of Active Saskatchewan
- Be able to actively participate in open and careful deliberation on all matters

- Board members can sit for a maximum of six (6) continuous years.
- Nominees must be in good standing as a current Active Saskatchewan member or represent a current member organization.
- The nomination must be supported by two other members.
- Nominees must indicate their willingness to stand for nomination, either by signing the nominations form or by attaching an e mail note expressing their interest.
- Newly elected Directors shall assume office at the close of the Annual General Meeting, Tuesday, June 5, 2018, following the election.
- Nominees must submit a biographical paragraph detailing their suitability as a Director for Active Saskatchewan.
- The Directors receive no remuneration.
- Directors must be willing to commit the time necessary to carry out the duties of a Board member.
- Nominations will be accepted by the Nominations committee up to 12:00 noon, Friday April 20, 2018.
